### Scott Perra (2-3 minutes)

Good morning and thank you for joining us today.

I'm Scott Perra, president and CEO of Mohawk Valley Health System. This morning we are here to announce a collaborative effort that will expand access to potentially lifesaving technology across the Mohawk Valley.

The program we will talk about today is linked with the Mohawk Valley Heart Institute, which was established in 1997 as a collaborative effort of Faxton St. Luke's Healthcare and St. Elizabeth Medical Center. MVHI has exceptional physicians and staffs that have helped us grow into one of the premier cardiac care facilities in New York State. At MVHI we continue to develop new treatments, support research, and improve the lives of those who come to us for care.

MVHI has been working with Excellus to help take the lead on expanding access to mobile, diagnostic technology for our EMS providers. Let me introduce to you Eve Van de Wal who will explain.

# **Eve Van de Wal (4-5 minutes)**

Good morning. I'm Eve Van de Wal, regional president of Excellus BlueCross BlueShield.

I want to thank Scott and St. Elizabeth Medical Center for graciously hosting this press conference here today.

Recently we became aware of a need in our community to provide municipal and volunteer ambulance services with 12-lead electrocardiogram modems. These modems allow first responders to transmit vital diagnostic information directly from individuals who have an acute myocardial infarction or heart attack symptoms to hospital emergency departments. The advance data sent via the 12-lead ECG can speed triage and treatment once the patient arrives at the hospital, lowering a patient's risk of death and serious damage to the heart muscle.

Today we're pleased to announce that we have pledged a \$120,000 grant to the Mohawk Valley Heart Institute to expand the availability of this lifesaving diagnostic technology to our neighbors in the community.

At Excellus BlueCross BlueShield, we believe that providing access to high-quality health care is core to our mission as a nonprofit health plan. Our Community and Member Health Improvement program provides grants to initiatives that bring together numerous community partners, span multiple years and include specific objectives and measurable outcomes in improving health. We are particularly interested in efforts that address cardiovascular disease.

There are a number of individuals who, through their determination and desire, worked to make this funding possible. I'd like to acknowledge of Tom Norton and Cheryl Perry at the Mohawk Valley Health Institute for working with us in getting this technology into transport vehicles across the Mohawk Valley. I want to recognize Vinny Faraone, EMS Clinical Coordinator for the Midstate Emergency Medical Services council, and representatives from local EMS agencies, many of who are here today and will be instrumental in getting these 12-lead ECG modems up and running.

And I would like to acknowledge the commitment on behalf of Excellus BlueCross BlueShield's chief medical officers, Drs. Frank Dubeck and Marybeth McCall, in working

with the Mohawk Valley Heart Institute and the EMS services to respond to an identified need in the community.

Now I'd like to ask Dr. Frank Dubeck to say a few words about the grant....Dr. Dubeck....

## Dr. Frank Dubeck (2-3 minutes)

Last year, the health plan worked with SUNY Upstate Medical University and the Central New York EMS Council to place modems in ambulances across Central New York and we quickly recognized the value in pursuing similar partnerships in our all regions.

We're really pleased that we were able to find such a strong partner in the Mohawk Valley Heart Institute.

While Mohawk Valley Heart Institute the recipient of the grant dollars, today's announcement is about supporting the community....our municipal and volunteer emergency medical services agencies, the emergency medical technicians and ultimately our neighbors.

As a doctor, I have seen first-hand the impact of heart disease. I know the importance of early detection, and early intervention. And, as all medical personnel know when faced with a cardiac emergency, time is always of the essence.
