It seems like we just turned the page to 2017 and here it is ending. EMS continues to evolve from agencies to the State, it truly is an exciting time in this business.

Similarly, to across New York State the Midstate Region has seen 3 ambulance services merge with neighboring services to create stronger and more dependable services. One Midstate Basic Life Support First Responding Agency no longer responds to EMS calls.

Finally, after years of trying New York State has a Collaborative Protocol, the process involved regions across the state and a lot of "give and take". It is a tribute to the dedication of our REMAC's and the State Emergency Medical Service Council, that we have achieved this consistent level of care across New York.

The Basic EMT level of care continues to increase, this year we have added Epinephrine Injection, now included in all original and recert classes, Albuterol for severe respiratory distress (not just asthma) and blood glucose testing to name a few. The State has created a committee to review and report on a complete "overhaul" of our BLS Protocol

The Department of Health terminated original Critical Care classes starting January 1, 2018. Recertification will remain available through both traditional and CME programs. The Bureau is working on a Critical Care to Paramedic Bridge currently under construction and we should see that program in January.

Pre Hospital Electronic charting ePCR in New York State will be moving from Nemsis 2 to Nemsis 3 a much more robust data collection system. Look for implementation in the first quarter of 2018.

Lee Burns our New York State EMS Director has announced her retirement at the end of 2017. Lee has been a constant and vigilant supporter of EMS in New York State. Her dedication and commitment to all EMS has been an inspiration on behalf of all Midstate Providers and Agencies we wish her well and thank her for her support

### AMERICAN HEART ASSOCIATION RELEASES NEW CPR GUIDELINES

On October 18, 2015, the American Heart Association released the new CPR Guidelines for Cardiopulmonary Resuscitation. Many EMS providers and CPR Instructors have called to question when the changes will go into effect and what are those changes. I have been advised by Mike Dickinson, Regional AHA Coordinator the following: It is strongly recommended to go to the official AHA website to view and review the new 2015 CPR Guidelines. This is the AHA Website address: www.americanheart.org. There was a significant cost increase for all HEARTSAVER card costs. This includes Heartsaver CPR/AED, First Aid, First Aid/CPR/AED and Pediatric First Aid/CPR/AED. The cost of these cards will now be \$20.00 as opposed to \$5.00 from the past. Health Care Provider cards will be \$5.00 until further notice.

# **CLINICAL COORDINATOR INFORMATION**

#### Collaborative Protocol's

Since March 1<sup>st</sup>, 2017, 372 ALS providers have attended the Midstate Collaborative Protocol Rollout and have passed the accompanying Protocol Test for their level of care. This number includes the ALS providers who were already standing at the time of the rollouts, as well as a handful of new comers to the region and newly carded ALS providers.

To date, there have been some learning points. From the hospital side, we've had a hand
ful of discussions about the lack of IV's on "ALS patients." After years of ALS-ing

a patient

being defined as no less than, cardiac monitor and IV, the sudden arrival of patients without the IV was met with some concern. The acceptance of this way of treating our patients has gotten better. The understanding now is that the IV is still to established in anticipation of a fluid bolus or med administration but not attempted for "precaution only".

Also, the NYS BEMS and Trauma stated at spring SEMSCO meeting that the Collaborative Protocol's include both ALS <u>and</u> BLS direction. And, although the Collaborative Protocol's BLS section does not match the standing NYS BLS Protocols completely, BLS providers are able to follow protocols as they are listed in the Collaborative Protocols. This being said, the BLS administration of albuterol is no longer just for asthmatics. BLS providers can administer albuterol to patients with exacerbation of their COPD or who are experiencing Bronchospasm. Just remember, all administrations of albuterol by a BLS providers is tracked by the REMAC. Therefore, if you used it then please be sure to fill out and submit the QA form. Subsequently, if you are an agency who doesn't' already carry REMAC approved albuterol for BLS providers, just jump on the Midstate website and download the application for Albuterol for BLS and get started!

#### New & Exciting

At the fall meeting, the SEMSCO and SEMAC approved the administration of epinephrine via IM injection by BLS providers. This new addition the BLS scope of practice allows agencies to replace the expensive epinephrine auto-injectors (and the previous alternative, Check-n-Inject) that their BLS providers use, with epinephrine 1:1000 vials and a 1cc syringe. In order to have your agency make this change, just go to the Midstate website and download the <u>Midstate Syringe Epinephrine for Basic EMT's</u> from the FORMS page.





## Faxton-St. Luke's EMS Education Information

In the blink of an eye, 2017 is gone. 2017 has been a great year in the Education Department here at Faxton-St. Luke's. We have completed 10 Basic Classes with 265 students completing and certified. Our Critical Care class finished in March of this year with 19 students certified as Critical Care Techs. Currently, our last Critical Care Class has a current enrollment of 23 Originals and 2 Refreshers. We are completing the first AEMT class with 13 students in December and our Paramedic program completed in June with 17 certified as NYS Paramedics.

We are pleased that our Paramedic Distance Learning program was approved, and Beta testing has been successful. Current attendance for the Paramedic program has been good with 33 current Originals and 2 Refreshers. Our on-line CME program remain solid and we are pleased with provider results and will continue in 2018 with our almost monthly CME recertification programs. In 2017, we have been providing quarterly National Registry BASIC EMT Practical Skills Examinations as the national requirements have changed in April of this year. This is an added benefit to students who wish a dual NYS and National Certification.

I am pleased to announce additions to our teaching team. This year we have added Anthony Arrigo as a CLI & CIC (intern), Hilary Rounds CLI, Dan

Roeback CLI, Daniel Gigliotti CLI, John Barattini CIC, Jeff Jones CIC, Diane Howe CIC (intern), Darrell Hogan CLI(intern), and Melissa Lockwood CIC. In addition, with the implementation of the new Instructor Testing and requirements 10 Instructors have tested and passed the new CIC requirements. Nice Job by all!

- \*Register for the class at midstateems.org
- \*Bring verification of participation in the CME program.


#### **REQUIREMENTS:**

- \*Agency must be registered with State Bureau of EMS (BEMS)
- \*Participants of the agency must be registered with state
- \*Provider card must be current.
- \*All providers must complete 72 hours of Continuing Education over 3 year period
  - \*Of that 72 there are mandatory core content hours
- 26 for EMT, 26 for A EMT, 36 for Critical Care, 48 for Paramedic
- \*The core content hours must be taught by a CIC (state EMS Instructor).
- \*EMS Education offers the core content hours thru an online program
- \*This program is accessed thru the hospital Net Learning system

#### The Program:

- \*One classroom session
- \*Presentations on Net Learning
- \*Tests at the end of each presentation
- \*Module exams
- \*Once all presentations and tests are successfully completed the state paperwork will be signed by the CIC and sent to you via mail.

#### REGIONAL MEDICAL DIRECTOR'S REMINDERS

**Trauma & Pregnancy**: Any pregnant trauma victim, meeting trauma criteria, will be directed to the Trauma Center at St. Elizabeth Medical Center.

<u>Poison Control versus Medical Control:</u> Patients who present to EMS with suspected or confirmed overdose should receive direction from Resource Medical Control. Resource will direct EMS based on the type of exposure or ingestion the appropriate course of EMS action.
